Subject: LPG Sales Tax Exemption

On August 7, 2001, Governor Davis signed AB426 which according to the State Board of Equalization (BOE) shall be effective starting on September 1, 2001.

AB426 provides for a permanent sales tax exemption on liquid petroleum gas (LPG) when used for residential and agricultural purposes. Those purposes are specified in the bill as follows:

## **Revenue and Taxation Code Section 6353**

(b) (1) Liquefied petroleum gas, delivered to a qualified residence by the seller, that is sold for household use in the qualified residence or liquid petroleum gas that is purchased for use by a qualified person to be used in producing and harvesting agricultural products; provided, in either case, the liquid petroleum gas is delivered into a tank with a storage capacity for liquid gas that is equal or greater than 30 gallons.

- (2) For purposes of this subdivision:
- (A) "Qualified residence," means a primary residence, not served by gas main and pipes.
- (B) "Qualified person", means any person engaged in a line of business described in this paragraph in producing and harvesting agricultural products.

The BOE has indicated that they are working on a "Special Tax Notice" and a "Tax Information Bulletin" to explain the provisions of AB 426. They anticipate that it will be in the mail by the end of August. In the meantime in order for our customer's to qualify for the exemption they must fill out completely, and sign a certification form, (copy enclosed), and return to Allied Propane Service offices in either Richmond, Napa, or Dixon. Please do not send it in with your payment; mail directly to the office that serves you. The Certification Form has been reviewed and approved by the BOE.
